I. 申請資訊 Application information

一、申請時間：2023 年 01 月 01 日（日）至 03 月 01 日（三）止。

Application time: January 1 (Sunday) to March 1 (Wednesday), 2023.

二、申請程序 Application Procedure

步驟一 Step 1	請先確認您的「身分」符合外國學生申請資格。 請參考簡章第 2-4 頁 申請資格-身分認定 。 Please make sure that you are eligible to apply as an international student. Refer to Eligibility-Nationality on page 2-4.
步驟二 Step 2	請確認您的「學歷」符合申請資格。 請參考簡章第 5-7 頁 申請資格-學歷規定 。 Please make sure that your education background is qualified for the intended program. Refer to Eligibility-Academic Background on page 5-7.
步驟三 Step 3	請確認您欲申請的系所及學位當年度有開放招收外國學生。 請參考簡章第 8 頁 招生系所 。 Please make sure the program that you intend to apply is open to international students. Refer to Program on page 8.
步驟四 Step 4	準備申請所需文件（包括申請文件及系所另行規定之文件）。 Prepare all required documents (including additional required documents by the individual department/institute to which the applicant intends to apply).
步驟五 Step 5	請於外國學生入學申請表上黏貼照片，並於同意具結書上簽名。 Stick photo on application forms; sign your name on the Declaration for International Students.
步驟六 Step 6	於 申請截止日（2023 年 3 月 1 日） 前將申請文件以掛號郵寄或超商宅配方式郵寄或親自送件至「72045 臺南市官田區大崎里 66 號，國立臺南藝術大學教務處註冊組」，以郵戳為憑。建議使用可追蹤之快遞服務。海外地區建議使用 DHL 或 FedEx 等國際快遞服務。親自送件受理時間：週一至週五，09:00am~5:00pm。 Before the application deadline (March 1, 2023), the application documents should be mailed or delivered in person by registered mail or supermarket delivery to " 66, Daqi, Guantian Dist., Tainan City 72045, Taiwan Registration Section, Academic Affairs Office, National Tainan University of the Arts ", based on the postmark. It is recommended to use a traceable express service. In oversea areas, it is recommended to use international express services such as DHL or FedEx. Delivery time in person: Monday to Friday, 09:00am~5:00pm. The application packet must be submitted either in person or by express mail to the address indicated below prior to the application deadline (must be postmarked by March 1, 2023).

三、申請資格-身分認定 Eligibility-Nationality

符合以下申請資格之一者，得依外國學生身分申請入學。申請係依據教育部《外國學生來臺就學辦法》所規定，辦法如經修正，將依教育部公告為準。

One who is qualified with one of the following conditions can apply for admission as an international student. The application qualifications are based on Ministry of Education (MOE) International Students Undertaking Studies in Taiwan. If the MOE updates or changes the regulations, all applicants must follow the new regulations.

- (一) 具外國國籍且未曾具有中華民國國籍(註 1)，並於申請時不具僑生(註 2)資格者。

An individual of foreign nationality is defined as one who has never held nationality status from the Republic of China (Note 1) and who does not possess Overseas Chinese Student status (Note 2) at the time of his/her application.

- (二) 具外國國籍且符合下列規定，於申請時並已連續居留(註 3)海外六年(註 4)以上者。

An individual of foreign nationality, pursuant to the following regulations, who has continuously (Note 3) stayed overseas for no less than six years (Note 4).

所謂海外，指大陸地區、香港及澳門以外之國家或地區。

The term “overseas” is limited to countries or regions other than Mainland China, Hong Kong and Macau.

1. 申請時兼具中華民國國籍(註 1)者，應自始未曾在臺設有戶籍。

An individual who also is a national of the R.O.C., but does not hold nor has had a household registration in Taiwan.

2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An individual who also was a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by Ministry of the Interior.

3. 前二款均未曾以僑生(註 2)身分在臺就學，且未於當學年度經海外聯合招生委員會分發。

An individual referred to in the preceding two subparagraphs must have never previously undertaken studies in Taiwan as an overseas Chinese student nor have accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic year.

- ※依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前二項規定之限制。

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval.

- (三) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者。前所謂海外，不包括大陸地區。

An applicant of foreign nationality, holding a permanent residence status in Hong Kong or Macau, and has never held a household registration record in Taiwan, who, at the time of application, has resided in Hong Kong, Macau, or another foreign country for no less than six years. China is not defined as the abovementioned foreign country.

(四) 曾為大陸地區人民，具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。

An applicant of foreign nationality, who has been a former citizen of Mainland China and has no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than six years.

※持香港永久居留資格且持有英國國民（海外）護照者，應不認定具有英國國籍，不得以外國學生身分申請來臺就學，應以僑生身分向海外聯招會申請入學。

Those holding a permanent residence status in Hong Kong and also a British National (Overseas) passport are not eligible to apply as international students. They can only apply as an Overseas Chinese Student to the University Entrance Committee for Overseas Chinese Students.

※如違反上述任一條件，經查者屬實者，撤銷其入學資格、開除學籍或撤銷其本校畢業資格，且不發給任何學歷證明。

Any violation related to abovementioned eligibility is not allowed to apply for any program as an international student, and will result in the annulment of the admission, deprivation of the status of the admitted student, and no diploma will be issued.

※外國學生來臺就學後，其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，即喪失外國學生身分，應予退學。

During the course of study in Taiwan, international students, who have undertaken initial household registration, resident registration, naturalization or restoration of the R.O.C. nationality, will lose the international student status and shall be dismissed by the school.

※外國學生申請來臺就學，以一次為限。於完成申請就學學校學程後，除申請碩士班以上學程之外，如繼續在臺就學者，其入學方式應與我國內一般學生相同。外國學生已在臺完成學士以上學位，繼續申請碩士以上學程者，得具我國各校畢業證書及歷年成績證明文件，依規定申請入學。

International students applying for schools in Taiwan shall be limited to one application only; an exception is that an application for a master's degree or higher levels of graduate studies. Upon completion of the course of study, at a school in Taiwan, to which an international student has applied, the student's admission to another school's academic level shall be handled in a manner identical to the admission procedures for local students. However, international students who have completed their bachelor's degree (or above) in Taiwan and wish to apply for higher education are eligible to this application procedure.

註 1：以上所稱中華民國國籍，係依中華民國《國籍法》第二條所認定，有下列各款情形之一者，屬中華民國國籍：

- 一、出生時父或母為中華民國國民。
- 二、出生於父或母死亡後，其父或母死亡時為中華民國國民。
- 三、出生於中華民國領域內，父母均無可考，或均無國籍者。
- 四、歸化者。

Note 1: According to the Article two of the Nationality Law, a person shall have the nationality of the Republic of China under any of the conditions:

- (1) His/her father or mother was a national of the Republic of China when he/she was born.
- (2) He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the Republic of China at the time of death.
- (3) He/she was born in the territory of the Republic of China, and his/her parents can not be ascertained or both were stateless persons.
- (4) He/she has undergone the nationalization process.

註 2：僑生請逕向海外聯合招生委員會申請。所稱僑生，指「海外出生連續居留迄今，或最近連續居留海外六年以上，並取得僑居地永久或長期居留證件回國就學之華裔學生」。

Note 2: Overseas Chinese Students should apply to the University Entrance Committee for Overseas Chinese Student. Overseas Chinese Students are “Overseas Chinese Students who were born overseas and have resided continuously from birth to date, or have stayed overseas continuously for the most recent 6 years, and possess permanent or long-term residence permit.”

註 3：所稱連續居留，指外國學生每曆年(1 月 1 日至 12 月 31 日)在國內停留期間不得逾 120 日；所謂海外，指大陸地區、香港及澳門以外之國家或地區。至連續居留採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內有無在臺停留逾 120 日予以認定。

但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

1. 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
2. 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿 2 年。
3. 交換學生，其交換期間合計未滿 2 年。
4. 經中央目的事業主管機關許可來臺實習，實習期間合計未滿 2 年。

Note 3 : The term “continuously” means that an individual stays in Taiwan for no more than a total of 120 days per calendar year; the term “overseas” is limited to countries or regions other than Mainland China, Hong Kong and Macau. If the continuous residence does not start and end within the entire calendar year (January 1 to December 31), the residence is determined by whether the stay in Taiwan has exceeded 120 days.

The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supported proof:

- (1) Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or techniquetraining classes accredited by the Ministry of Education (the “Ministry”);
- (2) Attended a Mandarin Chinese center approved by the Ministry, and to which the total length of stay is less than two years;
- (3) Exchange students, whose exchange program is less than two years; or
- (4) An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than two years.

註 4: 所定六年，以擬入學當學期起始日期(8 月 1 日)為終日計算之。

Note 4: The six years calculation period shall be calculated from the starting date of the semester (August 1) as the designated due date for the time of study.

四、申請資格-學歷規定 Eligibility-Academic Background

(一) 境外學歷 Overseas Academic Credentials

持境外學歷者，須符合中華民國教育部相關學歷採認法規，並於註冊入學時繳交相關證明文件（如附件九），未能繳交相關證明文件或資格不符者，取消入學資格。

All overseas academic credentials have to confirm to relevant regulations by the Ministry of Education (MOE) of R.O.C. Taiwan. At the time of registration/enrollment at the school, those holding overseas academic credentials have to submit related documents verified by Taiwan overseas representative offices (see attachment 9). Otherwise their admission will be annulled.

(二) 學歷要求-學士班 Academic Background Requirements-Bachelor's Programs

1. 具以下資格者得申請本校學士班：

Applicants who meet the following qualifications may apply for admission to the University's undergraduate program:

(1) 高級中學畢業生。

Those with senior high school diploma;

(2) 高級中學應屆畢業生。

Those who are expecting their senior high school diploma in the current academic year;

(3) 符合「入學大學同等學力認定標準」有關學士班報考資格者（如附件十三）。

Those with equivalent educational level (to that of Taiwan's academic degree system) for entering bachelor's programs (attachment 13).

2. 畢業年級相當於國內高級中等學校二年級之國外或香港澳門地區同級同類學校畢業生（中五學制畢業生），得以同等學力申請本校學士班，但至少應增修 12 個畢業應修學分始得畢業，並另外繳交學分費，增加之畢業應修科目由各學系訂定。上述畢業生不含「已離校兩年以上者」。

Those having graduated from a foreign high school or junior college in a period equal to Taiwan's grade 2 high school education counterpart (those from five-year secondary education program) may apply for the undergraduate program. However, if accepted, the admitted students have to take at least 12 additional credits and pay extra credit fees before graduation. The subjects of the additional credits are to be designated by each individual department. The abovementioned graduates exclude those who have graduated for more than two years.

3. 曾在臺灣以外國學生身分申請並完成高中學校學程者，不得依此辦法申請本校學士班，其入學方式應與我國內一般學生相同。但外國學生在臺灣就讀外國僑民學校或高級中學附設之雙語部（班）者，得以外國學生身分申請入學。

Applicants who have applied for and finished high school as international students are not allowed to apply for admission to the undergraduate class, and should apply in the same way as ROC students. However, international students who enroll in boarding school or bilingual department of high school in Taiwan may apply for enrollment as international students.

(三) 學歷要求-碩士班 Academic Background Requirement-Master's Programs

具以下資格者得申請本校碩士班：

The following are eligible for application:

1. 具學士學位者。
Those with bachelor's degree;
2. 學士學位課程應屆畢業生。
Those who are expecting their bachelor's degree in the current academic year;
3. 符合「入學大學同等學力認定標準」有關碩士班報考資格者（如附件十四）。
Those with equivalent educational level (to that of Taiwan's academic degree system) for entering master's programs (attachment 14) .

(四) 學歷要求-博士班 Academic Background Requirement-Doctoral Programs

具以下資格者得申請本校博士班：

The following are eligible for application:

1. 具碩士學位者。
Those with master's degree;
2. 碩士學位課程應屆畢業生。
Those who are expecting their master's degree in the current academic year;
3. 符合「入學大學同等學力認定標準」有關博士班報考資格者（如附件十五）。
Those with equivalent educational level (to that of Taiwan's academic degree system) for entering doctoral programs (attachment 15) .

(五) 依教育部規定，外國學生凡曾遭入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再經由本管道申請入學。違反此規定並經查證屬實者，撤銷其所獲准入學資格。

International students, who have been dismissed by from universities/colleges after admission due to behavior issues, poor academic performances or a conviction under the Criminal Law, are not allowed to apply for admission via this channel. Should any of the above violation cases be verified, the applicant's student status will be revoked immediately.

(六) 外國學生所繳入學證明文件有偽造、假借、塗改等情事，應撤銷錄取資格；已註冊入學者，撤銷其學籍，且不發給任何相關學業證明；如畢業後始發現者，應由學校撤銷其畢並註銷其學位證書。

An international student submitting forged, fabricated, or altered papers for the purpose of their school application shall be subject to enrollment qualification cancellation; or a revocation of enrollment and denial to the request of any certificate pertaining to study, if the said student is already enrolled; or revocation of graduation qualifications and cancellation of the diploma by the student's school, if the said student has been already graduated.

(七) 前學歷在大陸地區取得者，須符合以下規定：

Applicants with a previous degree from China are subject to the following regulations:

1. 學校屬教育部「大陸地區高等學校認可名冊」所列。
The university where the previous degree was obtained must be listed under MOE's "List of Recognized Higher Education Institutions in Mainland China."

2. 修業期間符合《大陸地區學歷採認辦法》第 7 條最低門檻。
The period of study must fulfill the minimum requirements of Article 7 of MOE's Regulations on Academic Qualifications from Mainland China.
3. 無《大陸地區學歷採認辦法》第 8 條所列不予採認情形。
One must not meet any circumstance listed under Article 8 of MOE's Regulations on Academic Qualifications from Mainland China.

(八) 根據中華民國教育部相關學歷採認規定，持境外機構所核發之學力鑑定考試及格證明者，其學歷不符合申請資格。
In accordance with MOE's regulations regarding the recognition of academic credentials, holders of passing certificate of appraisal of academic achievement examination issued by foreign institutes are not eligible for application in terms of academic background.

Should there be an insufficient number of students admitted, the quota of each department can be used mutually.

六、修業年限 Length of study

學士班學生修業年限為四年，如未能在規定年限內修滿學分者，得延長修業年限，延長修業年限至多以二年為限。

研究生修業期限碩士班為一年至四年，博士班為二年至七年。

The length of study for undergraduate students is four years, if they fail to complete the credits within the prescribed period, they may be extended to two years at most.

The postgraduate study is one to four years for a master's program and two to seven years for a doctoral program.

七、甄審日期、方式及地點 Date, method, and location of evaluation

(一) 日期：2023 年 03 月 13 日至 04 月 10 日 (依各系所規定之甄審時間)。

Date: March 13 to April 10, 2023 (evaluation time varies with departments)

(二) 甄選方式：以資料審查為主，面試視各系所而定，如需面試，各系所將另行通知申請者。

Screening : Screening is mainly based on application material review. Audition or interview is up to each individual program. Departments/Institutes will contact the applicants if an interview is required.

(三) 地點：各招生系所 (依各系所規定之甄試時間及地點為準)。

Location: all departments available (according to time and location for interview for various departments.)

八、語言要求 Language Requirement

大部份的課程皆以中文授課，申請人應具備適當的中文聽、說、讀、寫能力。每個系所對於中文能力可能有不同要求，招生系所有個別規定者，則依其規定。

Most courses are conducted in Chinese. Applicants are expected to have sufficient listening, speaking, reading and writing ability in Chinese language. Language requirements may differ from program to program. If required otherwise, the applicants should follow the individual requirements demanded by the intended departments or graduate programs.

If the issue is discovered after the student graduates from the school, both diploma and degree will be cancelled.

International students are not allowed to apply for in-service training courses for undergraduate and postgraduate, along with other courses that only take place during evenings and holidays. However, international students with a residential permit for foreigners, permanent residential permit, and those who enroll in specific international courses regulated by the Ministry of Education are not limited by the act.

(十一) 本校將於 2023 年 6 月公告註冊入學相關資料，錄取考生請依本校規定完成新生報到及註冊手續。未依規定辦理報到手續者，取消其入學資格，考生不得有異議。

The school will announce the registration and enrollment information in June of 2023. Admitted candidates should complete the registration and registration procedures for new students by the school's regulations. During the registration of international students, new students should present health and injury insurance document in effect for at least six months after entering the country (notarization from oversea embassies required). Current students should submit a certificate of ROC's National Health Insurance, and the expiration date should be within the study period in Taiwan. Applicants who are not insured (enrolled students only) may submit the insurance fee during registration, and have the school handle the insurance procedure. If the insurance certificate is issued by Overseas institutes, the certificate has to be approved by Overseas embassies.

一、本校為公開辦理外國學生新生招生入學考試工作，依教育部外國學生來臺就學辦法第六條規定訂定「國立臺南藝術大學外國學生來臺就學規定」(以下簡稱本規定)。

In order to publicly process admission for recruiting foreign students, Regulations for International Students Undertaking Studies in Taiwan of Tainan National University of the Arts has been founded according to the sixth article of International Students Undertaking Studies in Taiwan of Ministry of Education.

二、具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者，得依本規定申請入學。

Applicants with foreign citizenship who possess no ROC citizenship, and possess no qualification of Overseas Chinese student while applying may enroll in the school.

具外國國籍且符合下列規定，且最近連續居留海外六年以上者，亦得依本規定申請入學。

Applicants with foreign citizenship and who meet the following regulations, in addition to residing continually for more than six years, may also enroll in the school.

(一) 申請時兼具中華民國國籍者者，應自始未曾在臺設有戶籍。

Applicants who possess R.O.C. citizenship (note 1), should never have registered at a household in Taiwan.

(二) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

For applicants who possessed R.O.C. citizenship before submitting application, eight years must have passed since the Ministry of Interior declared loss of R.O.C. citizenship.

(三) 前二款均未曾以僑生身分在臺就學，且未於當學年度經海外聯合招生委員會分發。

The two occasions above did not occur while the applicants studied in Taiwan as Overseas Chinese student, and have not been overseen by University Entrance Committee for Oversea Chinese Students.

依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。

According to the educational cooperation agreement, foreign citizens who have been recommended to enroll in Taiwanese institutions by a foreign government, institute, or school, are not restricted by the former two limits should the applicants not obtain household registration in Taiwan.

第二項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。The span of six years and eight years should start from the beginning date of enrollment (Feb.1 or August 1st).

第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：Oversea regions indicate nations or regions other than Mainland China, Hong Kong, and Macao. Continual residency indicates international students (January 1st to December 31st) who have not stayed within R.O.C. border for 120 days. The residency of applicants who retain residency within an incomplete year, would be considered to be less than 120 days that year. The residency within R.O.C. is not considered a part of the Overseas residency:

（一）就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

The applicant enrolls in an Overseas youth technical training class or technical training class approved by Ministry of Education

（二）就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

The applicant studies in the Chinese language center of various colleges that have been approved by Ministry of Education to accept international students for less than two years.

（三）交換學生，其交換期間合計未滿二年。

Exchange student whose residency is less than two years.

（四）經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

The applicant attends an internship granted by supervisors for less than two years.

具外國國籍並兼具中華民國國籍，且於教育部外國學生來臺就學辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。Applicants with both foreign and R.O.C. citizenship who withdrew their R.O.C. citizenship before “International Students Undertaking Studies in Taiwan” was enacted on February 1st, 2013, may apply for study without being limited by the second regulation.

三、具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依本規定申請入學。

Applicants with foreign citizenship and permanent residency in Hong Kong or Macao, in addition to lacking household registration in Taiwan, have resided in Hong Kong, Macao or Overseas regions for more than six years, may apply for study in accordance with the regulation.

前項所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入前項連續居留期間計算。

Continuous residency refers to international students who have not stayed within ROC borders for 120 days. However, applicants who meet one of the regulations from the 1st to the 4th in the 5th section is not limited by it. Residency within R.O.C. is not considered part of Overseas residency: 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依本規定申請入學。

Applicants who were once residents of mainland China, in addition to possessing foreign citizenship, are not registered in Taiwan, and have resided Overseas for over six years, may apply for enrollment. 前項所稱連續居留，指每歷年在國內停留期間，合計未逾一百二十日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外連續居留期間計算。

Continual residency indicates international students who have not resided within ROC borders for 120 days. However, applicants who meet one of the regulations from the 1st to the 4th in the 5th Section is not limited by it. The residency within R.O.C. is not considered a part of the Overseas residency:

第一項及第三項所定六年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。The span of six years in the 1st and 3rd sections should start from the date of enrollment (February 1st or August 1st).

第一項至第四項所定海外，準用前條第五項規定。

The Overseas definition from the 1st to the 4th sections is applicable to the 5th section.

四、外國學生依前二條規定申請來臺就學，以一次為限。外國學生申請來臺就學，於完成申請就學學校學程後，除申請碩士班以上學程，得依本校外國學生來臺就學規定辦理外，如繼續在臺就學者，其入學方式應與我國內一般學生相同。

International students can only apply to study in Taiwan once in accordance with the previous two regulations. After the completion of an application for enrollment, applicants who study in Taiwan should apply in the same way students of R.O.C. do, except those applying for a master's degree.

五、本校實際招收入學之外國學生，其名額以教育部核定本校當學年度招生名額外加百分之十為原則，並應併入當學年度招生總名額報教育部核定；申請招收外國學生名額超過當學年度核定招生名額外加百分之十者，應併同提出增量計畫（包括品質控管策略及配套措施）報教育部核定。

The number of international students enrolling in the university should be more than ten percent of the Ministry of Education's annual admission quota, and should be certified by the Ministry of Education. When the number of admitted international students exceeds ten percent of the expected number of students, the school should propose an added-on plan (including strategies for quality control and a back-up plan) and submit it to the Ministry of Education for approval.

於當學年度核定招生總名額內，有本國學生未招足情形者，得以外國學生名額補足。

第一項招生名額，不包括未具正式學籍之外國學生。

When there is an insufficient number of Taiwanese students, the quota can be met with international students. The number of admission in the 1st sector does not include international students who have yet to be enrolled formally.

六、本校招收外國學生新生，悉依本規定辦理之。

Admission of new international students should follow regulations detailed on the form.

本校外國學生招生簡章，應詳列招生學系（所）、修業年限、招生名額、申請資格、甄選方式、錄取原則及其他相關規定。

The application form for international students at the university should list available departments, study span, number of admissions, qualifications for application, method of evaluation, admission principles and other regulations.

七、申請入學之外國學生，應於每年1月1日至3月1日前，檢附下列文件逕向本校註冊組申請入學（以一系所為限），經審查或甄試合格者，發給入學許可：

International students who wish to apply for enrollment should send out the application to the university's Registration Division with the following documents (one department only) between January 1st to March 1st each year. Those who pass the evaluation or interview may be admitted to the university.

（一）入學申請表。

Enrollment application

（二）學歷證明文件：

Certificates of study

1. 大陸地區學歷：應依大陸地區學歷採認辦法規定辦理。

Education from Mainland China: Certified through Certificate Regarding Education from Mainland China.

2. 香港或澳門學歷：應依香港澳門學歷檢覈及採認辦法規定辦理。

Education from Hong Kong or Macao: Document should comply with Regulations Governing the Examination and Recognition of Education Qualifications from Hong Kong and Macao.

3. 其他地區學歷：

Education from other areas:

(1) 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。
Oversea Taiwanese schools and Taiwan Businessmen's School which are equivalent to the same level of an ROC school.

(2) 前二目以外之國外地區學歷，應依大學辦理國外學歷採認辦法規定辦理。但設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

Applicants should manage education received from the previous two subjects according to Recognition of Foreign Education for Universities. However, if the overseas schools are based in Mainland China, such schools should be notarized by the institutes in Mainland China, and evaluated by civilian groups established or selected by the Executive Yuan.

(三) 足夠在臺就學之財力證明，或政府、大專校院或民間機構提供全額獎助學金之證明。
Financial statement that proves the applicant's capability to study in Taiwan, or certificate that proves provision of scholarship from government, colleges, or civilian institute.

(四) 各系所規定之其他文件。

Other documents required by departments.

本校審核外國學生之入學申請時，對前項第二款、第三款、第四款未經我國駐外機構、行政院設立或指定之機構或委託之民間團體驗證之文件認定有疑義時，得要求經驗證；其業經驗證者，得請求協助查證。

During the evaluation of the application of international students, the university has to request verification when there is doubt regarding documents not notarized by ROC embassies, civilian groups established or selected by the Executive Yuan in terms of the 2nd, 3rd, and the 4th section.

外國學生已在臺完成學士以上學位，繼續申請入學碩士班以上學程者，得檢具我國各院校畢業證書及歷年成績證明文件，依規定申請入學，不受第一項第二款規定之限制。

外國學生在我國就讀外國僑民學校或我國高級中等學校附設之雙語部（班）或私立高級中等以下學校外國課程部班畢業者，得持該等學校畢業證書及歷年成績證明文件，依規定申請入學，不受第四點規定之限制。

When international students who have completed their bachelor degree of above in Taiwan apply for postgraduate studies, applicants should submit their diploma and transcripts from ROC schools and apply without being limited by the 2nd article of the first section. International students who study in schools for international residents or graduated from bilingual classes at ROC high schools, or foreign classes in private high schools, may apply for enrollment with diploma and transcript without being limited by the fourth section.

外國學生註冊時，新生應檢附已投保自入境當日起至少六個月效期之醫療及傷害保險，在校學生應檢附我國全民健康保險等相關保險證明文件。

During enrollment for international students, new students should submit certificates of medical and injury insurance valid for at least six months after entering the country; current students should submit certificates for National Health Insurance or other related insurance.

前項保險證明如為國外所核發者，應經駐外機構驗證。

If the insurance certificate is issued by foreign institutions, it should be notarized by R.O.C. embassies.

七之一、外國學生所繳入學證明文件有偽造、假借、塗改等情事，應撤銷錄取資格；已註冊入學者，撤銷其學籍，且不發給任何相關學業證明；如畢業後始發現者，應由學校撤銷其畢業資格並註銷其學位證書。

Should any documents from international students be discovered to have been forged, faked, or the submitted documents corrected, their qualification shall be cancelled without any certificate for enrollment. If the issue is discovered after the student graduates from the school, both diploma and degree will be cancelled.

八、本校對外國學生學籍管理，應即時於外國學生資料管理資訊系統，登錄外國學生入學、轉學、休學、退學或變更、喪失學生身分等情事。

In managing the student status of international students, the university should register entrance, transfer, dropping out, expulsion, change, or loss of student identity on the management system for international students' information.

九、外國學生申請入學之資格先由各系所初審，再經招生委員會議予以複審，各（系）所於初審階

段必要時得通知申請人接受專業科目或中國語文能力測驗。

The application of international students shall be evaluated by the departments initially, and will be re-evaluated by the enrollment committee. All departments have to inform applicants to take a professional ability or Chinese ability test.

- 十、外國學生註冊入學時，未逾該學年第一學期修業期間三分之一者，於當學期入學；已逾該學年第一學期修業期間三分之一者，於第二學期或下一學年註冊入學。

During the registration of international students, students who register before the first third of the semester should enroll in the current semester. Students who apply later than the first third of the first semester of the academic year will have to enroll in the second semester or next academic year.

- 十一、外國學生就學應繳之費用，依下列規定辦理：

Tuition fees for international students should comply with the following regulations:

- (一) 經駐外機構推薦來臺就學之外交部臺灣獎學金受獎學生及具我國永久居留身分者，依本校所定本國生收費基準辦理。

Applicants who are recommended by foreign embassies for Taiwanese scholarship from the Ministry of Foreign Affairs and those who possess permanent residential permits will be charged according to the standard of domestic students.

- (二) 依教育合作協議入學者，依協議規定辦理。

Applicants who enrolled through the educational cooperation agreement shall follow the terms of the agreement.

- (三) 前二款以外之外國學生，由本校所定外國學生收費基準，報教育部核定並不得低於同級私立學校收費基準。

International students other than the previous two types will be charged the international rate which has been certified by the Ministry of Education and should not be lower than the charging rate of an equivalent private school.

教育部外國學生來臺就學辦法中華民國一百年二月一日修正施行前已入學之學生，該教育階段應繳之費用，仍依原規定辦理。

Students who have enrolled before the enactment of “International Students Undertaking Studies in Taiwan of Ministry of Education” should follow the same rate as before.

- 十二、外國學生不得申請就讀我國大專校院所辦理回流教育之進修學士班、碩士在職專班及其他僅於夜間、例假日授課之班別。但外國學生在臺已具有合法居留身分者或其就讀之班別屬經教育部專案核准之課程者，不在此限。

International students are unable to apply for Recurrent Education for undergraduate, in-service master class, and other classes which are exclusively evenings and holidays. However, international students with Taiwan residential permits or who are enrolling in a class approved by the Ministry of Education are not limited.

- 十三、外國學生於我國大學畢業後，經學校核轉教育部許可在我國實習者，其外國學生身分最長得延長至畢業後一年。

International students who graduate from universities in R.O.C. and are approved by the Ministry of Education to participate in an internship in Taiwan may extend the identity of international students a year after graduation.

外國學生來臺就學後，於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，喪失外國學生身分，應予退學。

After international students enroll in Taiwanese institutes, one who establishes household registration, moving-in registration, naturalization, or retaining R.O.C. citizenship, would no longer be qualified as an international student, and would be dismissed from the school.

外國學生經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再依本規定申請入學。

International students who have been expelled from school due to a moral issue, failed academic performance, or criminal activity should not apply for enrollment through this method.

外國學生轉學，依本校學則及本校「轉學生招生規定」辦理。但外國學生經入學學校以操行不及格或因刑事案件經判刑確定致遭退學者，不得轉學進入本校就讀。

International students applying for transfer should follow the regulation of the university's Regulation for Transferred Student. International students who have been expelled from school due to a moral issue, failed academic performance, or criminal activity should not be allowed to

transfer to the school.

- 十四、在不影響正常教學情況下，得與外國學校簽訂教育合作協議，招收外國交換學生；並得準用外國學生入學規定，酌收外國人士為選讀生。

Where no circumstances affect classes, the university may sign educational cooperation agreements when recruiting Overseas exchange students. Regulation for Enrollment of International Students may be followed to select foreigners as students.

- 十五、因國際學術合作計畫或其他特殊需求成立外國學生專班，依總量發展規模與資源條件相關規定，報教育部核定。

Establishing specific classes for international students due to international academic program or other requirements may require approval from the Ministry of Education in accordance with their scale and resource requirements.

- 十六、本校為鼓勵外國學生來臺就學，自行提撥經費設置外國學生獎學金。

In order to encourage international students to study in Taiwan, the university has established scholarships for international students.

- 十七、本校教務處註冊組負責辦理外國學生入學申請案件。

Registration Unit of Academic Affairs Division is in charge of applications of international students.

外國學生在校平時生活與學業之輔導、考核、聯繫事項，由本校學務處與各該所屬系（所）負責；並加強安排住宿家庭及輔導外學學生學習我國語文、文化等，以增進外國學生對我國之了解。應於每學年度不定期舉辦外國學生輔導活動或促進校園國際化，有助我國學生與外國學生交流、互動之活動。

Consulation, evaluation, and communication with international students regarding school life and academic issues will be in charge of Student Affairs' Divions and individual departments. Homestay accommodation and education regarding Chinese language and culture will be arranged as well in order to improve international students' understanding of R.O.C. Consulation program for international students will be hosted to encourage communication between R.O.C. students and foreign students.

外國學生有休學、退學或變更、喪失學生身分等情事，學校應通報外交部領事事務局及學校所在地之內政部移民署各服務站，並副知教育部。

Should issues arise such as expulsion, dropping out, or change in or loss of student identity, the university should inform the Bureau of Consular Affairs of the Ministry of Foreign Affairs, and the local office of the Immigration Department of the Ministry of the Interior along with the Ministry of Education.

- 十八、凡依本規定入學之外國學生，可依「國立臺南藝術大學外籍生獎學金設置要點」相關規定，申請獎學金。

International students who enroll according to the regulations may apply for a scholarship through the Tainan National University of the Arts.

- 十九、外國學生有違反就業服務法之規定經查證屬實者，本校應立即依規定處理。

Should international students be discovered to have violated the Employment Services Act, the university shall deal with the issue immediately.

- 二十、本規定未盡事宜，悉依教育部「外國學生來臺就學辦法」暨有關規定辦理。

Should such regulation fail to resolve the issue, it should be dealt with by "International Student Undertaking Studies in Taiwan" of the Ministry of Education.

- 二十一、本規定經招生委員會議通過，並報請教育部核定後實施，修正時亦同。

The regulation has been passed by the enrollment committee and has been approved by the Ministry of Education.

- 一、為配合教育部擴大招收外國學生來臺留學政策，並鼓勵優秀外國學生至本校就讀，特訂定「國立臺南藝術大學外國學生獎學金設置要點」（以下簡稱本要點）。
- 二、本要點所稱之外國學生，係指符合「國立臺南藝術大學外國學生來臺就學辦法」第二條第一項及第二項規定申請資格入學之外國學生。
- 三、本獎學金受獎期限：
 - (一) 各級學位最長受獎期限，大學部四年、碩士班二年、博士班四年；惟每名受獎生受領本獎學金期限累計不得超過五年。
 - (二) 自註冊入學起，至畢業離校、休學或退學月止。但延長修業年限期間，不得申請。
- 四、本獎學金名額及金額如下：
 - (一) 大學部每學年六名，每名新臺幣四萬元整；碩（博）士班每學年七名，每名新臺幣六萬元整。
 - (二) 受獎學生須於申請當年度註冊入學，始得領取本獎學金。
 - (三) 本校外國學生獎學金總金額及各學制獎助名額，得視各年度經費預算及申請人數情況而彈性調整。
- 五、申請資格：
 - (一) 新生：依本要點第二點申請入學，並經招生委員會複審通過錄取之外國學生；再由國際學術交流審查小組擇優核定獎勵名單，公布並通知受獎人。
 - (二) 舊生：在本校就學一學期以上具有正式學籍之外國學生，並符合下列規定：
 1. 大學生：前一學期至少須修習十六學分，學業平均成績達七十五分以上，且未受學校申誡以上處分者。
 2. 研究生（含碩、博士生）：前一學期至少須修習二門課程，學業平均成績達八十分以上，且未受學校申誡以上處分者。
 3. 研究生（含碩、博士生）已修滿畢業學分者，於撰寫論文期間無前一學期成績者，前一學年學業成績總平均達前款規定，另須提供指導教授推薦函及論文撰寫計畫。（須包含研究動機與目的、研究架構與設計、資料蒐集來源、論文大綱、參考書目），且未受學校申誡以上處分者；此類申請以一次為限。
 4. 擔任本校學生社團負責人，前一學年學業成績總平均達七十分以上，或碩士班或博士班達七十五分以上，得以擔任社團負責人證明及社團活動成果報告提出申請；此類申請以一次為限。
- 六、申請時間與核定期程：
 - (一) 獎學金以學年為核定單位，分上下學期兩次發放。
 - (二) 新生：配合該年度招生時程，依國際事務處公告期間內提出申請。
 - (三) 舊生：每年九月十五日至九月三十日前向國際事務處申請。
- 七、申請資料：
 - (一) 新生：依國際事務處公告方式申請。
 - (二) 舊生：
 1. 本處提供之申請書。
 2. 推薦函 1 封（導師或指導教授）。
 3. 前一學期成績單證明。
 4. 作品集或其他專業表現，有利於審查之文件。
- 八、審核標準：

(一) 新生：由國際學術交流審查小組擇優核定獎勵名單。

(二) 舊生：由國際學術交流審查小組依下列指標與評分比例核定獲獎名單，公布並通知原申請學生。

1. 學業成績占總分 40%。

2. 作品集或其他專業表現占總分 60%。

九、依據「國立臺南藝術大學國際交流獎補助計畫校內審查辦法」第三條規定，國際學術交流審查小組成員由國際事務處主任擔任主席，教務長、學務長、及相關學院院長組成。

十、已獲得教育部臺灣獎學金或本校獎學金者，不得重複申請本獎學金；若有溢領情事，一經查證屬實，應予繳回。

十一、受核定通過獎勵之學生，入學當年度未完成註冊、辦理保留入學資格、休學、退學、轉學或畢業離校者，取消其獲獎資格；休學後再復學者，亦取消其繼續獲獎資格。

十二、領取本獎學金者，經查若有偽造或不實之情節，本校得撤銷其獲獎資格，已領取之獎學金應繳回學校。

十三、本要點經行政會議通過，陳校長核定後實施，修正時亦同。

Tainan National University of the Arts International Student Scholarship Guidelines

Reviewed/Approved on August 5, 2009 in the first administrative meeting of the academic year 2009.

1. The “Tainan National University of the Arts – International Student Scholarship Guidelines” (hereinafter referred to as “the Guidelines”) were established to support the government policy of increasing recruitment of international students in Taiwan and to encourage outstanding international students to study at the University.
2. The “International Students” referred in the Guidelines means foreign students who have met the admission qualifications prescribed in Article 2, Paragraph 1 and Paragraph 2 of the “Tainan National University of the Arts – Regulations Governing International Students’ Study in Taiwan”.
3. Maximum Duration of the Scholarship:
 - (1.) The maximum duration of the scholarship varies depending on the level of degree pursued: Four years for undergraduates, two years for a master’s degree and four years for a doctoral degree. For each student, however, the accumulated period of receiving the scholarship should not exceed five years.
 - (2.) A student shall be eligible for applying the scholarship from the date of his/her enrollment in the school until the date of his/her graduation, suspension, or withdrawal from the school. Students are not allowed to apply for the scholarship during the period of extended study.
4. Number and amount of the scholarships:
 - (1.) Six scholarships are offered to undergraduate students for each academic year, at a value of NT\$40,000 for each student. Seven scholarships are offered to students seeking master’s (doctoral) degrees for each academic year, at a value of NT\$60,000 for each student.
 - (2.) The scholarship is only available to students who have completed enrollment procedures for the specific year.
 - (3.) The total value and number of the international scholarship for different study programs shall be adjusted based on the budget for the year and the number of applicants.
5. Application Criteria:
 - (1.) New Students: The eligible candidates should be international students who have applied to the University according to Article 2 of the Guidelines and been admitted by the Student Recruitment Committee. The International Academic Exchange Assessment Committee shall review the applications and determine the recipients of the scholarship. A notice shall be sent to the awarded candidates accordingly.
 - (2.) Existing Students: Existing students who have studied at the University for more than one semester and is maintaining a regular student status may apply for the scholarship if they meet the following requirements:
 - a. Undergraduate Students: The applicant must have completed at least 16 credits during the preceding semester, with an average score of 75 or above. The student should not have received admonition or more severe disciplinary measures from the school.
 - b. Graduate Students (students seeking master’s or doctoral degrees): The applicant must have completed at least 9 credits or above during the preceding semester, with an average score of 80 or above. The student should not have received admonition or more severe disciplinary measures from the school.
 - c. In the event that a graduate student (a student seeking master’s or doctoral degrees) has completed all the required credits but does not have any academic record for the preceding semester when he/she was engaged in thesis writing, the student should meet the average scores stipulated in the preceding two items. The applicant should, in the meantime, submit a

recommendation letter issued by the thesis advisor and the dissertation research proposal (including the motivation and objectives of the research, its structure and design, the source of information, summary of the dissertation and references, etc.). In addition, the student should not have received any admonition or more severe disciplinary measures from the school. Only one submission is allowed for these applicants.

- d. Foreign students who have acted as the leader of student clubs with an average academic score of 70 or above during the previous academic year (75 or above for students under the master or doctoral programs) may also apply for the scholarship by submitting the relevant certificates for the leadership or the achievement reports for the student club. Only one submission is allowed for such applicants.

6. Schedule of the Application/Review Process

- (1.) The application and review shall be administered once each academic year. Two payments shall be made each year, respectively each semester.
- (2.) New Students: The scholarship shall be offered according to the schedule of the annual recruitment process. Applications should be submitted according to the schedule announced by the Office of International Affairs.
- (3.) Existing Students: Applications should be submitted during the period from September 15 to September 30 each year.

7. Application Documents:

- (1.) New Students: Please follow the procedures announced by the Office of International Affairs.
- (2.) Existing Students:
 - a. The application form provided by the Office.
 - b. One letter of recommendation. (From the tutor or thesis advisor)
 - c. Transcript of academic performance for the previous semester.
 - d. Portfolio or other favorable documents to prove the professional achievement of the applicant.

8. Assessment Criteria:

- (1.) New Students: The selection shall be made by the International Academic Exchange Assessment Committee.
- (2.) Existing Students: The International Academic Exchange Assessment Committee shall determine the winners of the scholarship based on the following criteria. The results shall be announced and advised to the applicants.
 - a. Academic achievements 40%.
 - b. Portfolio and other professional achievements 60% .

9. Pursuant to Article 3 of the “Tainan National University of the Arts – Internal Assessment Guidelines for International Exchange Scholarship/Subsidy Programs”, the International Academic Exchange Assessment Committee shall be organized by the dean of academic affairs, dean of student affairs and the deans of the related colleges. The Committee shall be chaired by the director of the Office of International Affairs.

10. Students who have already received the Taiwan Scholarship granted by the Ministry of Education or other scholarships granted by the University shall not be entitled for this scholarship. They shall be demanded to return the funds unduly received, if confirmed after an investigation.

11. The entitlement for the scholarship shall be voided if the recipient fails to complete the enrollment procedures, has applied for reservation of school admission or for suspension of schooling, or has transferred out or graduated from the University during the year when the admission is granted. Students who have resumed study after a suspension of schooling shall not be eligible for continuous receipt of the scholarship.

12. The scholarship shall be withdrawn in case that the recipient is found to have provided false or misleading information. The fund received by the student should be returned to the University accordingly.

13. The Guidelines shall be implemented after it is resolved in the Administrative Meeting and approved by the President of the University. The same procedure shall apply for all future amendments.
